On 9 December 2012 I forwarded you an email asking if disclosure statements for members of the Working Group and Oversight Committee for [The Science of Immunisation: Questions and Answers](#) publication were publicly available on the Australian Academy of Science website (see below).

I also forwarded [emails to Sir Gus Nossal](#) on this matter. While I have received a brief response from Sir Gus Nossal in the meantime, I have not as yet received a response from the Academy of Science.

The Science of Immunisation: Questions and Answers publication promotes the use of vaccine products. **I suggest it is essential that any potential conflicts of interest of the Working Group and Oversight Committee be disclosed.** For instance, [according to The Conversation website](#), Professor Ian Frazer receives royalties from the sale of HPV vaccines in the developed world. As far as I can see, this pertinent information is not recorded in [The Science of Immunisation: Questions and Answers](#).

**Do other members of the Working Group and Oversight Committee have any potential conflicts of interest to disclose?**

Sir Gus has advised me of his status in this area. Unfortunately, his email carried the caveat: ***"The information in this email is confidential and intended solely for the addressee. You must not disclose, forward, print or use it without the permission of the sender"***, which rather misses the point of my enquiry...

Also, it has come to my attention that Professor Frazer made the following statement in relation to my request for disclosure statements:

*Colleagues*

*I'm sure we should do this though it will be used (and probably abused) by Elizabeth Hart who evidently has a thing about vaccines (which she believes are overused by both the medical and the veterinary professions.)*<sup>[1]</sup>

Professor Frazer is correct in his assumption that I believe vaccines are overused by both the medical and the veterinary professions.

Along with my colleague Bea Mies, I have undertaken extensive investigation and correspondence on veterinary vaccination, as detailed on my website, refer to this webpage: [Over-vaccination of pets – an unethical practice](#). The media has also reported on this matter, see for example the report by consumer watchdog CHOICE: [Pet vaccination – Over-vaccinating your pet could be harmful to their health as well as your own hip pocket](#) and the ABC's report: [Questions raised over pet vaccination](#).

Professor Frazer's suggestion that I would 'abuse' information related to disclosure statements is uncalled for. The public is entitled to transparency and accountability for vaccination practice, and this is seriously lacking at the current time. **My website [Over-vaccination – Challenging Big Pharma's lucrative over-vaccination of people and animals](#) seeks to help redress this matter.**

**Professor Cory, I request your early response to my enquiry about disclosure statements.**
