**I suggest the NVIC is failing in this stated mission as you have ignored the issue of children being possibly needlessly over-vaccinated with the second dose of live Measles/Mumps/Rubella (MMR) vaccine.**

I first brought this matter to your attention [back in September 2013](#) when I forwarded you [my letter to Paul Offit](#) regarding the arbitrary second dose of the live MMR vaccine. I was most disappointed to receive a response from Gina Bernazzani (17 September 2013) advising you weren't 'available' to critique my letter to Paul Offit.

Since that time, no doubt millions of children around the world have been over-vaccinated with the second dose of live MMR vaccine, a medical intervention which may have been unnecessary, particularly for the measles and rubella components.

I have now brought this matter to the attention of a number of people. I am appalled by the obstructionism I have encountered on this matter, **and the reluctance to properly inform parents and other individuals of the option of antibody titre testing to verify immunity after the first dose of live MMR vaccine.**

**Most recently I have forwarded an email (see below) and attached letter to Secretary Sylvia Mathews Burwell, US Department of Health and Human Services, challenging the mandated second dose of live Measles/Mumps/Rubella vaccine, and lack of information about antibody titre testing. **In particular, I think it is important to consider NVICP Authorizing Legislation Sec. 300aa-26 in regards to mandated vaccination, and also [The Antibody Titer Law \(Holly's Law\)](#) in regards to MMR over-vaccination. How can 'informed consent' be given to a medical intervention that is mandated? There is a real tension here, and it needs to be highlighted.**
